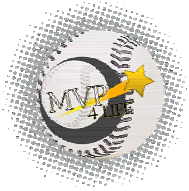

TERMS OF UPPER DECK APPLICATION AND PARTICIPATION

- This agreement represents the complete understanding between the APPLICANT and MVP4Life. No representations, written or oral, other than those contained within this agreement are authorized by or binding upon MVP4Life.
- Payment for the Upper Deck League must be paid in full no later than May 15, 2011, entitling APPLICANT to use The Strike Zone facility within the scope of participation in the league as set forth by MVP4Life in agreement with The Strike Zone. Applicant may choose to pay in full or by monthly payments for the term of this agreement at \$ ___ per month (Credit Card Information or Checking Account and Routing number are required).
- Management of MVP4Life or The Strike Zone may suspend or cancel the rights, privileges, or membership of any applicant whose actions are detrimental to the enjoyment of The Strike Zone facilities or Upper Deck League by other members and applicants.
- MVP4Life may, from time to time, change the rules or regulations governing the operations of MVP4Life and the Upper Deck League. Notice of these changes will be made available to members through normal means of communications.
- The Applicant will be liable for payment of all costs incurred by MVP4Life in the collection of past due payments to MVP4Life.
- The Applicant acknowledges and accepts the risks inherent in the use of MVP4Life/The Strike Zone/The Upper Deck League services, facilities, and participation in the Upper Deck League. By use of The Strike Zone facilities, services and Upper Deck League Participation, the applicant hereby voluntarily assumes the risk of injury, accident, death, loss, cost, or damage to his or her personal property which might arise from the use of MVP4LIFE services, The Strike Zone facilities, or/and Upper Deck League Participation.
